7. The exchange of sustainable development information between communities and cooperation in comparative studies (Laghayi et al., 1999)

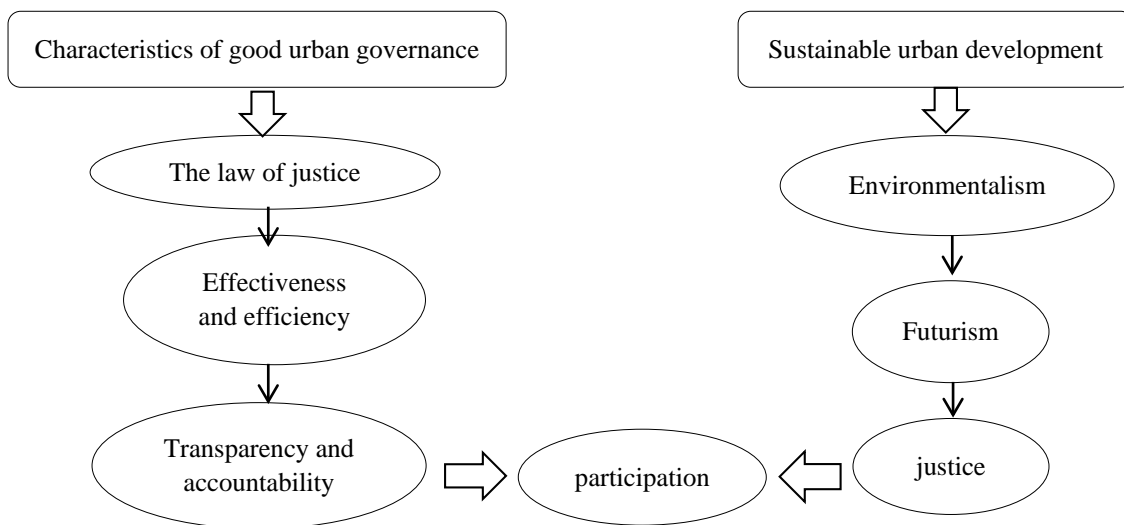
Therefore, its development is a process that seeks to create a sustainable city suitable for the present and future lives of its citizens.

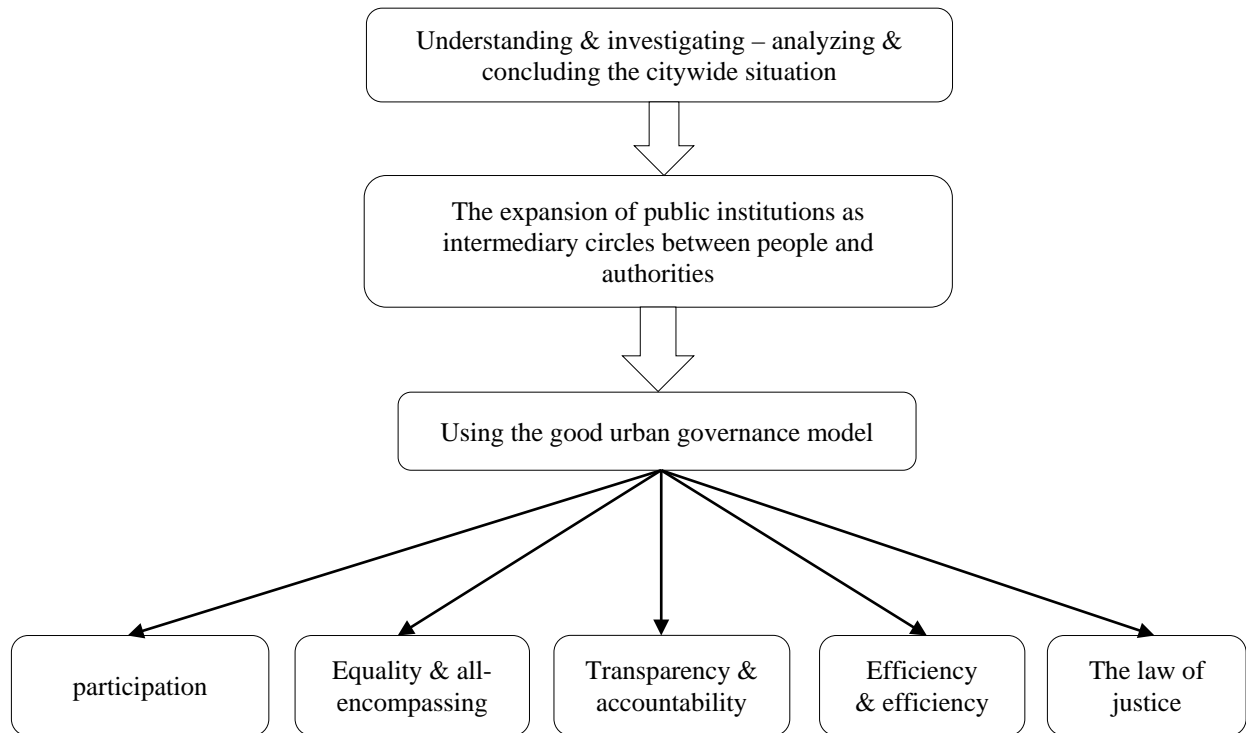
